On **April 14th** Finance Committee held the business meeting "Documented verification of a zero percent VAT rate for the sale of goods (labor & services)". The speaker of the meeting was Alexander V. Egorichev, Head of the Department of Desk Control of the Federal Tax Service of Russia. During the event Alexander covered such topics



as registering document information with zero VAT; order and algorithms for comparing and verifying VAT Information Registers; results VAT Information Registers verification and receipts from the 2016 tax period, including the main inaccuracies and errors in completing the registration

of information by zero VAT; development towards electronic shipment of documents; and prospects of Legislative Changes in Foreign Economic Activity.
