#### **May Highlights 2017**


On May 11th SPIBA held the event in the new format - Consular

Isabella spoke about the sensational case «Urgenda vs. the Netherlands», when Hague District Court has ruled that the State must take

more action to reduce the greenhouse gas emissions in the Netherlands at least 25% by 2020. Such a judgment addressed to the









government was the first of its kind in the world. Apart from Isabella Brand during the meeting there were presentations by Oleg Bokov, CEO of HEINEKEN Brewery, HEINEKEN Breweries, Maxim Titov, Executive Director, Research Center of the European University in St. Petersburg, and Angelina Davidova, Director at Russian-German Bureau of Environmental Information and environmental journal.
