### **October Highlights 2017**

**6 October** Logistics group of SPIBA Industrial organized a traditional Logistics Breakfast within the walls of the "Mikhailovskaya Dacha" campus of the Graduate School of

Management of SPSU. For five successive years, SPIBA together with





GSOM SPbU and ANCOR personnel organized holdina logistics а breakfast. This year the meeting was devoted to the prospects for the development of logistics. More than 60 representatives of production, 3PL and logistics companies – the largest players in the North-West Federal District market, took part in the business breakfast. Representatives from GSOM SPbU, ANCOR and MTS made presentations in the panel session. The interactive part of the





breakfast consisted of discussion in groups and subsequent presentation of the results of discussions on the topics: "Universal

soldier" or a narrow-focused specialist – who should I bet on?" and "ERP modules and WMS/TMS: what system to choose to improve the efficiency of logistics processes?" The participants of the business breakfast noted the relevance of the selected topics of the panel session and discussions.

The meeting was moderated by Vladislav



Zabrodin, Managing Partner of Capital Legal Services. Vladislav's speech was concerned not only with legal initiatives that the legislator introduced in 2017 but plans to bring in 2018. The presentation with the self-explanatory name "Cold Summer 2017 – will there be a "warm" winter

(legal results and prospects)" was a kind of marking the conclusion that reflected the brightest events of 2017 that influenced society and business. Stanislav Murashov, Macroanalyst of Raiffeisenbank, spoke





about the "vague prospects" of the Russian economy. He touched upon the recession of the economy,



the level of wages and inflation, the dynamics of investment demand, imports/exports and long-term growth. Anna Ustiyants, Operations Director of Kelly Services, shared with the audience the trends of the labor market in 2017 and gave predictions for 2018. Anna's predictions were based on such factors as the aging of the population, the struggle for talents, the flexibility of the work schedule, the robotization of the candidates selection process, the level of outsourcing and the attractiveness of the HR brand.

In conclusion, Julia Strelchik, Head of Marketing and Sales of the consulting and analytical company M-Brain, told the latest trends in the behavior of Russian consumers. Julia presented the quarterly report "Russian Consumer Insight", which contains information about Russian consumers, news of the consumer market and events reflected in the media.
