September Highlights 2016

On September 15th SPIBA HR Committee together with the Lobbying and Legislation Committee held the meeting dedicated to the practice in use of the Federal Law 242-FZ “On Amendments to Certain Legislative Acts of the Russian Federation in terms of clarification of the order of processing of personal data in information and telecommunications networks. Ernst V. Birikh, Deputy Head of Department for protection of the rights of personal data subjects and information technology Roskomnadzor Office for the North-West Federal District, commented on amendments made into the law on personal data and also answered all the questions from the audience. “Neste” representatives: Julia Petrova and Maxim Maximov told about the preparations they made for the planned inspection initiated by “Roskomnadzor” and further maintenance. Alexander Tarasenko, Associate, Baker and McKenzie, highlighted the topic from the legal point of view: “Inspections of Roskomnadzor in the legislation on personal data: the depth of inspection; typical violations; recommendations and decisions”.
