

Anton Poddubny, Advisor of the St. Petersburg practice of Dentons in the field of corporate law and M&A, outlined the main problems in the development of the Russian economy (sanctions, deterioration of infrastructure, low labor productivity, high state presence in the



economy) and listed the main directions for the development of legislation, areas for transforming the business climate and events of the Bank of Russia on the development of the financial market.

The forecast for the development of the labor market for 2018 (development of digitalization, flexible forms of employment, competition among employers, increasing the share of outsourcing, increasing the role of the HR brand for companies), which Anna Ustiyants, Commercial director, Kelly Services, gave a year ago, were mostly confirmed.

The round table ended with a presentation by Ekaterina Levochskaya, General Manager of M-Brain, who shared a study of socio-demographic and consumer trends.

On February 20th, there was SPIBA regular meeting within the series of events "Breakfast with the


Director". The invited guest was Ekaterina Gorokhova, General Director of Kelly Services CIS, General Director of the Association


