November Highlights 2019

On November 12, SPIBA Finance Committee continued the series of



meetings #SPIBATaxTalks in the new format "taxes and wine" with a discussion "Double Taxation Agreement Revolution: MLI in Russia". The event was held in an interactive format "talk show", where speakers were Anton Kabakov, Forte Tax&Law, Olga





Vorobyova, Emerging Markets Group, and Alexander Simonov, Mazars.

The audience took an active part in the discussion. During the meeting, the guests had time to discuss many aspects of the MLI Convention: from the basics of its application and the minimum standard to the optional provisions.

At the end, guests participated in the mind game of "tax specialists vs. taxpayers" on the passage of the Principal Purposes Test. Participants, previously divided into "tax" and "taxpayers", expressed

their "pros" and "cons" of whether the Principal Purposes Test will be passed in this case. Those teams whose arguments were considered the most compelling, received well-deserved prizes.
