On September 15, SPIBA HR committee held a round table "Labor Market Review". Timur Komarov, Head of Learning and Development, Gazprom Neft, moderated the event.

Special guest Nikolay A. Rogachev, First Deputy Chairman of the Committee on Labor and Employment of the Population of St. Petersburg, shared information on the level of employment and unemployment in St. Petersburg, as well as on the impact of the COVID-19 pandemic on the Russian labor market.

Anna Ustiyants, Operations Director Russia and Poland, Kelly, spoke about the current trends in the labor market. Anna answered how the pandemic affected the work format and staff employment, what factors motivate employees today, and many other questions.

Svetlana Orel, Manager, Specialized Labor Market Research Practice, Antal Russia, made a presentation "Results of the annual Antal Russia survey: job market overview in St. Petersburg and Russia in 2021". Svetlana shared the results of the survey, which included questions: how have salaries changed in 2020? how did 2020 affect careers? soft or hard skills: what is more important at work? online interview: for or against?

On September 29, after a long break, SPIBA held its Annual General Meeting, which included welcoming new members, Award ceremony 2020 and re-election of a member of the Executive Committee and the Executive Director of SPIBA.

The topic of the panel discussion of the meeting was "Low carbon economy today: trends and prospects". With the support of the Department of International Trade and the British Embassy in Russia, issues of concern to the whole world were discussed. Deborah Bronnert, Her Majesty's Ambassador to the Russian Federation, British Embassy, spoke about the UK's success in reducing greenhouse gas emissions and transitioning to a low carbon economy. Trevor Lewis, Counsel, Director of the UK International Trade Department in Russia, presents the UK experience in the field of modern low-carbon economy. Continuing the thopic of the ecological agenda, Tatyana Gorovaya, Government Relations Director, Nissan Manufacturing RUS, made a presentation "The role of electric vehicles in shaping the global eco-balance".

The presentation by Ali Mangera, Director of Mangera Yvars Architects (MYAA), "Sustainable Architecture for the Commercial and Industrial Sectors", raised a lot of excitement. Ali spoke about projects of cities of the future that already exist, and some of them are even being designed in our country.







Also in the panel discussion were Paul Wilkinson, Head of New Business Development (Europe), SLR Consulting, with the presentation on energy transition and decarbonization, and Deborah Sachs, Waste and Resources Specialist, UK Department of World Trade, with the presentation on waste management and plastic recycling.

Each of the speakers presented different aspects of clean energy but all unanimously noted that the issue of low carbon economy and climate change is a common one, and the world community can only solve it together.
